# "I'm Happy to see TLTB progressing well": Lalabalavu

The iTaukei Land Trust Board (TLTB)
Management Team visited the
President of Fiji, His Excellency Ratu
Naigama Lalabalavu, at the State House.

Led by CEO, Mr. Solomone Nata the team went to update the President on the work TLTB is doing — including improvements in land services and how the Board is working more closely with iTaukei landowners across the different provinces, Tikina, villages and landowning units.

Mr. Nata gave a short presentation on TLTB's current programs, new business direction, and how they aim to better serve the iTaukei.

President Ratu Naiqama thanked TLTB and its leadership team for their hard work.

"I'm happy to see the progress and the direction you're going in," he said. "I really like how you're now reaching out more

to landowners. This shows that TLTB is moving forward."

The President also talked about the important history of TLTB — reminding everyone that it's the only Board in Fiji that was originally linked to the British Crown when it was created in 1940.

He said it was sad that the President's role in the Board was removed by the previous government.

He encouraged TLTB to keep showing strong leadership and to help landowners make better decisions for their land and their future.

"This is a great time for TLTB to grow and become even better," he added.

"When a place is truly blessed, you will see it in the way people work together, services improve, and partnerships grow. That's what we're seeing at TLTB," he said.









Varavu Subdisivision in Ba nearing completion

#### More for Landowners in 2025: Varavu Subdivision in Ba

The iTaukei Land Trust Board (TLTB) has stepped into 2025 with a renewed purpose: to do more for landowners and ensure they benefit directly from the development of their land

One of the key highlights this

year is the Varavu Residential Subdivision in Ba — a major land development project fully funded by the Board.

Location: Varavu, Ba Landowning Unit: Tokatoka Masekonalagi, Mataqali Yasawa of Sorokoba Village Subdivision Details: 26 lots across 9.75 acres of native land Each lot ranges between 800 to 1000 square meters

With 90% of the works being completed, this project represents more than just real

estate — it's an investment by landowners, for landowners, through the support of TLTB. It's also part of a bigger direction in 2025 to put iTaukei landowners first, generate sustainable returns, and turn land into lasting opportunity.

#### **Nasealevu Water Catchment Lease Concerns**

The iTaukei Land Trust Board (TLTB) has taken proactive steps to address concerns raised by the landowners of the Nasealevu Water Catchment Area in Labasa regarding the lease agreement with the Water Authority of Fiji (WAF).

The landowners had raised several issues, including the construction and maintenance of an access road leading to their village, clarity on the lease issuance process, distribution of lease monies, and the verification of lease approvals. Additionally, they requested a Forest Inventory by the Department of Forestry to ascertain the value of merchantable timber and the construction of 12 fishponds as compensation

for the environmental impact caused by dam construction.

In collaboration with relevant stakeholders, TLTB has conducted multiple joint consultations with the landowning unit (LOU) members at Nasealevu village and the following resolutions have been made:

Access Road Construction: WAF has agreed to construct and maintain the access road, as they were previously unaware that this was a condition requested by the LOU.

Lease Documentation and Transparency: All requested information regarding the lease issuance process was provided to the LOU during consultations. TLTB also supplied a copy of the lease title and detailed lease statements for the four Mataqali within Yavusa Nasealevu—Luvutu, Vatuwa, Nasealevu, and Logani.

Merchantable Timber Inventory: The Department of Forestry has agreed to conduct an inventory assessment to determine the value of merchantable timber within the leased area.

Fishpond Feasibility Study:
The Department of Fisheries
conducted a feasibility study
on the proposed fishponds.
The study determined that
the water overflow from
the dam could only sustain
three fishponds instead of
the 12 initially requested
by the landowners. This
outcome has led to some

dissatisfaction among certain LOU members.

Concerns have also been raised over the involvement of an external consultant who has been reportedly influenced some LOU members to challenge the legitimacy of the lease title and disrupt water access at the Nasealevu catchment. The matter has now been escalated to the Commissioners' Office for further handling.

TLTB is working very closely with the LOU to address their concerns in an amicable manner. However, landowners have been advised against any actions to disrupt the Nasealevu Water Catchment.

#### \$295,000 Worth of Machinery Awarded Under TDF.

In a significant step towards landowner empowerment and economic self-sufficiency, the iTaukei Land Trust Board (TLTB) handed over machinery worth \$295,000 to four landowning unit (LOU) groups in a ceremony held in Nadi vesterday.

The event was officiated by the TLTB Chairman and Minister for iTaukei Affairs, Hon. Ifereimi Vasu. Speaking at the ceremony, Hon. Vasu highlighted the importance of economic empowerment through practical investment in tools and resources:

"This initiative is more than just a handover of machines. It represents the empowerment of our people to take ownership of their land, to build sustainable livelihoods, and to grow their own economies."

The four LOUs that received assistance today are:

#### Mataqali Nacobicibici Trust

Mataqali Nacobicibici Trust from Nasavusavu Settlement in Nalawa.Ra.

Mataqali Nacobicibic have been approved an advance of \$70,000.00 to purchase a Tractor and working capital to assist with their cane farming operations.

They have already leased an area of 84 hectares of land for sugarcane farming.

#### 2. Mataqali Duaira

Mataqali Duaira represents one of the landowning units within the Yavusa Nabuna, Nabuna village, situated in the Tikina of Tavua, Ba.

Mataqali Duaira Trust have been approved an advance of \$61,000.00 to purchase a tractor to assist with their cane farming operations. Members of the Mataqali have been engaged in cane farming with approximately 198 acres been cultivated.

#### 3. Yavusa Leweisavu

Yavusa Leweisavu in Momi Village, Tikina Momi,Nadroga have been approved advanced of \$79,000.00 for the purchase of a Tractor and Working Capital.

They have 1000 acres of vacant land which will assist them in their cash crop and cane farming operations.

#### 4. Tokatoka Bitowai Trust

Tokatoka
Bitoiwai,Mataqali
Leweivalaga is one of
the landowning units in
Yavusa Leweiwai in the
village of Nabila Village
Momi, Nadroga.

The Trust has been approved advance of

\$85,000.00 for the purchase of 3 tonne Truck to transport school children in their community and assist in transporting villagers to the market to sell their produce.

CEO, Mr. Solomone Nata, reaffirmed the organisation's commitment to helping landowners transition from passive land leasing to active participation in the economy.

"Through the TDF, we are addressing a key challenge that landowners have faced for years – access to capital. By investing in them, we're not just giving machines; we're creating opportunities for generations."

#### Rental Arrears Reduces By \$9.6m in 6 Months

he iTaukei Land Trust Board (TLTB) has successfully reduced its national rental arrears from \$31.6 million as at 1st January 2025 to \$22 million by 30th June 2025. This marks a significant reduction of \$9.6 million - representing a 30.45% decrease in just six months

CEO Mr Solomone Nata said this achievement reflects TLTB's firm commitment to fulfilling its legal obligation of collecting rent and ensuring

that landowners receive what is rightfully theirs from the use of their native land.

"This achievement was made at the back of an aggressive arrears recovery strategy that involves getting courts orders for disconnection of utilities and vacant possession of leased land across the country," he added.

Despite this progress, TLTB continues to urge tenants with long-outstanding arrears - some dating back 10 to 20

years - to settle their dues without further delay. These arrears cover all lease types and affect every region: Northern, North-Western, South-Western, and Central Eastern.

Failure to pay will result in legal enforcement, which may include:

- Applications for the disconnection of utilities, and
- Vacant possession of leased land, as ordered

by the courts.

TLTB reiterates its willingness to assist tenants through structured payment plans and encourages affected individuals or businesses to engage directly with TLTB offices.

# **TLTB Clarifies Land Consultation Concerns** Raised On Facebook

he iTaukei Land Trust Board (TLTB) wishes to clarify concerns raised in a social media video posted on 12 April 2025 by Mr. Mala Vuetibau regarding the alleged lack of consultation in the subdivision of a parcel of land located in Wainibuku, Kalabu.

The lease in question, originally issued for agricultural purposes, is situated on land owned by Mataqali Ulivi of Kalabu for 3.1364 hectares. Following multiple inspections and stakeholder consultations, the Board re-entered the lease in 2024 due to significant breaches of lease conditions, including the absence of cultivation and the presence of multiple unauthorized dwellings and a church.

Since February 2023, TLTB has undertaken the following:

Four consultations with members of Mataqali Ulivi between May 2023 and February 2024 regarding the re-entry process and the proposed residential subdivision.

The Mataqali was fully informed and had expressed their support for the relocation of tenants affected by EFL Wayleave leases to the new subdivision.

Re-entry of the lease was officially registered on 18

April 2024, after which planning commenced for the development of residential

In response to Mr. Vuetibau's claims, TLTB conducted a follow-up consultation on 14 April 2025. Present at the meeting were Mr. Vuetibau, other landowners, and TLTB officials, who provided clarification on the consultation processes and the subdivision development.

It was confirmed that Mr. Vuetibau did not attend the earlier consultation meetings, which may have contributed to his misunderstanding. TLTB presented documented meeting minutes as evidence of engagement and transparency with the landowning unit (LOU).

The meeting concluded with the following outcomes:

Formalisation of occupation on new leases two residential lots to the previous tenants, Mr. Ulaiasi Halofaki and Ms. Kesaia Tavaga, a church and two other occupants, subject to payment of premium, rent and costs.

The relocation of leases affected by EFL infrastructure will remain a priority.

Remaining lots will be held in abeyance pending further discussions with the LOU on their development plans.

Landowners have requested that agricultural leases nearing expiry be returned for incorporation into their own land-use plans.

TLTB reaffirms its commitment to transparent consultation and development planning with landowners. Future requests from the Matagali will be supported by land use planning assistance from TLTB. Landowners are encouraged to work together with TLTB on their development plans for better coordinated and sustainable land use and to consult with TLTB office first before spreading misinformation to the public.

Mr. Vuetibau has made some serious allegations that are libellous in nature, however he has apologised to our officers in yesterday meeting and was accepted.

#### Long - Standing Issue with Mataqali Navunibua

The iTaukei Land Trust Board (TLTB) is pleased to share that a long-standing land compensation matter with Mataqali Navunibua of Nayavu, Wainibuka has now been successfully resolved.

The Mataqali had raised a claim for royalty payment for gravel that was extracted from their land by the Public Works Department (PWD) back in 2008–2009 during the construction of the Kings Highway.

Due to a record error, the royalty payment made at that time was mistakenly allocated to a different Mataqali. After a thorough review and legal discussions, TLTB has today paid the outstanding \$150,000.00 to the Turaga ni Mataqali and Mataqali Navunibua Trustees — bringing closure to this long-standing matter.

This also marks the end of a High Court case filed by the Mataqali in 2019, which was formally settled through a Deed of Settlement in December 2024.

We thank Mataqali Navunibua for their patience and cooperation throughout this process. The Board remains committed to working with all landowners to ensure fair, transparent, and respectful administration of iTaukei land for the benefit of our people.

The Vuadomo community knew their land held great potential, but for years, outsiders reaped the benefits. When Muanivatu Trails emerged, TLTB stepped in to help secure the ecotourism lease, allowing them to develop their land in a way that respects their culture and values.

Through a \$30,000 low-interest loan from TLTB, Muanivatu Trails was able to build a wellness center, spa, and other key facilities. They have successfully repaid the loan, demonstrating not only their commitment but their ability to grow sustainably. This investment has boosted jobs, increased revenue, and raised their tourism lease value to \$1 million FJD—a true reflection of the

community's hard work and dedication.

Looking forward, the Vuadomo clan is preparing to develop 99 acres, including accommodation villas, family homes, and a commercial center. Construction of new tourism facilities starts this month, setting the stage for even more growth.

# Taukei Woman Thrives in Homestay Business in Kadavu

Situated in Namuana village, Tavuki, Kadavu. Ms Mereoni Vuase currently operates a home staying business that caters for tourism and even for local travellers including civil servants, that visit the island of Kadavu.

Located approximately two (2) kilometers from the Vunisea Government Station and 2.5km from the jetty, the homestay business boasts its central location and a stunning view by the beach allowing guests to witness the sunrise every morning and sundown every evening after a long day of work.

Commencing in 2022, the business provides three (3) rooms consisting of one (1) single bed and one (1) bed bunk to accommodate the

influx of visitors to the island.

To add on, the business provides a free laundary service as part of the package.

Being an iTaukei Woman, and a member of Mataqali Namuana, Ms Vuase excels in her hospitality service in utilizing the natural resources available.

"I do not spend a lot on food as most of the produce are from my plantation and from regular fishing out at sea" Cooking twice a day for guests, Ms Vuase always ensures that her guests are well fed in the morning as some may travel for long hours either by boat or by car.

"I normally prepare breakfast and dinner guests as they are usually out visiting villages throughout the day and return right in the evening".

Upon discussions with Ms Vuase, she shared that her driving force behind the business would be her Faith as a Seventh Day Adventist and her vision of providing a better life for her family.

"At the time, I was unemployed, living in the village, and struggling to make ends meet. Setting up this business three years ago has allowed me to provide a better life for my family while also providing an income stream that assists in our daily living."

"I thank God for opening this opportunity business for me as it has also allowed me to network, interact and socialize with guests from all walks of life.

Ms Vuase shared that despite the challenges faced, she hopes to renovate existing structures and expand the business in order to cater for the demands and bookings of guests visiting the island.

Looking at her operations, Ms Vuase is eligible to secure funding through the iTaukei Development Fund Facility; something that TLTB will pursue with her very shortly.

Ms. Vuase plans to include additional rooms and have two (2) of the existing rooms converted into master bedrooms. These master bedrooms will have their own showers and restrooms with extensions to her kitchen and dining area.

"TLTB is taking the lead, paving the way for landowning units (LOUs) and iTaukei individuals to embrace the idea — and believe — that we can own and operate businesses wherever and whenever we choose."

The special occasion was led by Reverend Savirio Vuata, Talatala Qase Wasewase Namoli, who conducted a small but meaningful church service attended by the Lautoka office staff. During the service, Rev. Savirio delivered an inspiring message from the book of Genesis, reminding the team that just as God entrusted man to manage and protect the Garden of Eden, TLTB staff are likewise entrusted to manage, protect, and serve the landowners of Fiji.

Following the service, the staff officially began their operations from the new premises; with 12 more office spaces open for rent in the heart of Lautoka City. The new

office is now fully operational, with the North-West team ready and committed to continuing their service to landowners and stakeholders with renewed energy and purpose.

This move represents not just a new physical space, but a fresh chapter in TLTB's journey towards growth, empowerment, and excellence in service delivery.

## New TLTB Service Centre in Namosi - A Province With Significant Development Potential

The iTaukei Land Trust Board (TLTB) reached another milestone in its new business direction yesterday (30th April 2025) with the official opening its third service centre — in Dada, Namosi, by the Turaga na Tui Namosi, Ratu Suliano Matanitobua.

Located within the premises provided by the Ministry of Rural and Maritime Development, the Dada TLTB Service Centre is set to bring vital land services closer to the people of Namosi — particularly the five tikina of Wainikoroiluva, Naqarawai, Veinuqa, Namosi, and Veivatuloa. This includes 72 mataqali from 28 villages

across 77,917 hectares of native land.

In his address, Turaga na Tui Namosi, Ratu Suliano Matanitobua, thanked the TLTB Board and its Management Team for their leadership and vision and rendered his full support. He urged those TLTB staff that will be serving from the new TLTB office, to consider themselves part of the Namosi province.

"Whenever you set foot on the land of Namosi, count yourself as one of us so that you can serve my people better. Because you will drink its water and eat its food – and though you may not way forward always sleep well or eat well – it will not matter, because vou are one of us." he said.

Ratu Suliano said the new office would become a hub for opportunity, learning, and prosperity for the people.

"Namosi has a lot of potential. We can help each other create wealth and assist the economy. But we must do it with care and love for one another. All provinces in Fiji must work together for this common goal," he said.

CEO Mr Solomone Nata said the event marked more than just an office opening — it symbolised the Board's commitment to decentralise services and extend outreach to remote and rural communities.

The new office will initially operate two days every fortnight, with the flexibility to increase operations based on local demand.

With only 16% of Namosi's land currently under lease, Mr Nata noted that more than 65,000 hectares remain unleased and hold significant development potential.

"This office will help facilitate land use planning with our landowners, create new economic opportunities, promote development projects that can lift the standard of living, and increase awareness of the assistance programs we offer such as the iTaukei Development Fund," Mr Nata explained.

Mr Nata reiterated TLTB's mission to not only manage leases, but to empower landowners with knowledge and confidence to drive economic growth.

"We want to encourage more of our landowners to farm and lease their own land; in ways that are sustainable, that respect our culture and traditions, and most importantly, that benefit our people," he said.

Apart from its Head Office in Suva, TLTB now operates:

- Four Regional Offices in Suva (Central Eastern Region), Nadi (South-West Region), Lautoka (North-West Region), Labasa (Northern Region) and the Tourism Office in Namaka.
- Six Sub-Regional Offices in Nausori, Ba, Sigatoka, Rakiraki, Korovou, and Savusavu.
- And three Service Centres in Nabouwalu, Vunidawa, and now Dada.

#### **Moves To Execute Eviction Orders**

The iTaukei Land Trust
Board (TLTB) is urging all
leaseholders with overdue
rent payments to urgently
clear their arrears, or risk
facing the consequences.
This reminder comes as
TLTB confirms that it will be
taking steps within this week
to execute eviction orders
obtained from court, marking
TLTB's ongoing commitment
and efforts to lawfully recover
rent owed to the iTaukei
landowners.

TLTB CEO Mr. Solomone Nata, said the decision to proceed with executing the eviction orders was not taken lightly, but was necessary to uphold the rights of landowners who have waited far too long to receive the lease income that is rightfully theirs.

"We have exhausted all reasonable avenues including reminders, notices, and payment plan arrangements," Mr. Nata said.

"The unfortunate reality is that continued non-compliance by certain tenants forces us to act in the best interests of landowners. These funds are critical for the livelihood, development, and well-being of the iTaukei landowners."

As at 1 January 2025, the opening rent arrears balance stood at \$31.6 million. To date, this has been reduced to \$24.8 million — indicating a recovery of \$6.8 million so far. This means we still have \$18 million yet to be recovered for the landowners.

The Board remains fully committed to upholding fairness, transparency, and accountability in the lease management process, with a strong focus on ensuring compliance with all lease terms and conditions.

However, failure by tenants to meet their obligations undermines this mandate and affects the trust placed in TLTB to safeguard landowners' interests.

The eviction orders will be executed in accordance with the law and due process, and further action may be taken if arrears persist across other leases.

Tenants are reminded that leases are legally binding

and must be honoured to maintain good standing with TLTB. He also encouraged leaseholders to proactively communicate with their nearest TLTB office to settle their lease arrears and avoid further legal action.

"We do not wish to evict anyone — but our first duty is to the iTaukei landowners. We are calling on all defaulters to do the right thing and come forward before it's too late," he added.

TLTB urges the public and stakeholders to support this initiative to uphold accountability and ensure the rightful beneficiaries — the landowners — receive what is lawfully due to them.

# \$2.75m Allocated for Construction of Access Farm Roads in Agriculture

Significant progress
has been made by the
iTaukei Land Trust Board
(TLTB) on one of the major
challenges for our agricultural
leaseholders today — the
lack of access roads to newly
subdivided agricultural lots.

With combined funding support from the Fiji Government and the iTaukei Land Trust Board (TLTB), a total of \$2.75 million — comprising \$750,000 from Government and \$2 million from TLTB — has been allocated for the construction

of farm access roads across four key agricultural subdivisions: Navunibua (Naitasiri), Nabulula (Tailevu), Navunisorua (Naitasiri), and Kasavu (Naitasiri).

TLTB confirms that the Navunibua access road has been completed, while road works continue on the remaining three sites.

CEO Mr. Solomone Nata said, "This investment is a significant step in unlocking the full potential of iTaukei land for agriculture and

improving rural livelihoods".

"We are grateful for the Government's partnership and the TLTB Board of Trustees and remain committed to delivering this project on time and within budaet."

The current delay in the

completion of Nabulula, Navunisorua, and Kasavu roads is due to unfavourable weather conditions and the presence of creeks along the construction routes.

The contractor, under TLTB's close supervision, is actively working on mitigation measures to ensure progress continues steadily.

The project is on track for completion by the end of June 2025, before moving to the next phase, which includes road gravelling and culvert installation.

"This initiative is about more than just roads," Mr. Nata

added. "It's about opening pathways to economic opportunity, empowering landowners, and providing the necessary infrastructure that will attract investors and enable farming activities to thrive.," he added.

# **New Tractor Allows Farming Efficiency for Duaira Trust in** Tavua

he iTaukei Land Trust The Hauker Land Hazz Board (TLTB), through its Taukei Development Fund Facility (TDFF), has provided financial support to the Duaira Trust of Matagali Duaira, one of the landowning units of Nabuna Village, in Tavua.

The \$61,000 funding allows Duaira Trust to purchase a brand new tractor, significantly modernizing their farming operations.

Matagali representatives Mr Sainivalati Nasau said this investment has streamlined land preparation and other essential farming tasks, leading to greater efficiency and long-term sustainability for the landowning unit.

"To date, the matagali has successfully cultivated up to four acres of land out of the 198 that they have using the

new machinery, supporting both sugarcane farming and the cultivation of watermelon. This dual-crop approach marks a strategic move toward diversification and enhanced land productivity," he added.

The tractor has reduced their reliance on external contractors and empowered the trust to manage operations independently. This initiative underscores TLTB's continued commitment to empowering iTaukei landowners through financial assistance and sustainable development programs. Through the TDFF scheme, TLTB is encouraging landowning units like Mataqali Duaira to actively engage in productive land use that fosters economic growth.

#### **Empowering the Landowners: A New Dawn For Naitasiri**

he iTaukei Land Trust Board (TLTB), through its Landowners Division, has taken a bold step forward in landowner empowerment with the launch of its very first Landowning Unit (LOU) Workshop for 2025. Held under the powerful theme, "Empowering Landowners for Successful Implementation & Sustainability of Development Projects," the workshop brought together 57 landowners from 14 landowning units (matagali) in the Tikina of Soloira. Nagaravakawalu, Viria, Navuakece and Nabaitavo in Naitasiri, at Navatukia Village, Serea on Thursday, 15 May.

This initiative is part of TLTB's ongoing commitment to help landowners move from potential to prosperity by unlocking the value of their land through knowledge,

collaboration, and action. This was done in collaboration with relevant Ministries that were presence to provide awareness and advice on the technicality and relevancy to be undertaken to ensure successful implementations of projects.

The workshop began with a heartfelt sharing and an inspiring address from Senior Landowners Officer, Mr. Pio Raitoni. Sharing his own observations from a recent trip to the Maori in New Zealand, Mr. Raitoni spoke passionately about indigenous communities there-scarce resources with immense development owned by the Maori or tribe through structural planning. His message to the people of Naitasiri was simple but profound:

- Form a committee of Trustees within each Matagali
- Create a long-term development vision
- Profile and understand the true potential of your land
- Tap into support systems like the iTaukei Development Fund Facility (TDFF)
- "You own the land—now own your future," Mr. Raitoni urged.

The second part of the workshop featured key presentations from Government and development partners, including the Ministry of Agriculture, the Ministry of Fisheries, and the Department of Cooperative, among others. These partners provided practical guidance on sustainable land use, funding opportunities, and income diversification.

Most inspiring were the landowner success stories shared—examples of progress from Mataqali Waimaro of Navoka village, Nabaitavo and Mataqali Navitilevu of Vatukorosia village, Navuakece. These were not just stories—they were blueprints for change.

The final part of the program was the handover of the Asset Capitalisation reports to the fourteen (14) Mataqalis who attended the workshop. The report covers Landowning unit profiling and the Landowners' Advisory Plan. The document is important for engaging with development partners to develop their resources and access funding through the TDFF or others of their choice.

# South Pacific with First-Ever Quantum Systems Trinity Pro Drone

The iTaukei Land Trust
Board (TLTB) has achieved
a historic milestone by
becoming the first institution
in Fiji and the South Pacific
to acquire and operate the
Quantum Systems Trinity
Pro drone—one of the most
advanced surveying drones
in the world today.

This breakthrough was demonstrated during a high-resolution topographic survey conducted in the Seaqaqa rainforest, where TLTB's Geospatial Information Coordinator and certified drone pilot, Mr. Isireli Buwawa, led the mission.

The state-of-the-art drone,

equipped with a LiDAR module and powered by Quantum-Skynode autopilot technology, was deployed to map the Matagali Waisavulu boundary-a critical component of the Fiji Hardwood Corporation Limited's upcoming forest certification project. With centimeter-level accuracy, the drone captured detailed 3D models of the terrain, revealing streambeds, erosion-prone areas, and

ancient terraces hidden beneath the dense forest canopy.

"This drone is more than just a flying camera—it's a game changer for environmental and land-use planning across the region," said Mr. Buwawa. "It enables us to capture data in just 60 minutes that would otherwise take weeks of manual fieldwork."

The Trinity Pro's VTOL (Vertical

Take-Off and Landing) capabilities, combined with a 60-minute flight endurance and dynamic terrain-following technology, make it ideal for Fiji's rugged landscapes. It is the first of its kind in the South Pacific, with swappable payload options including high-resolution RGB, multispectral, thermal, and LiDAR sensors.

This innovative leap aligns with TLTB's commitment to modernize its operations and empower landowners through smarter data-driven decisions for sustainable development.

"We're proud to be leading the way in digital transformation and geospatial intelligence in Fiji," said CEO Mr Solomone Nata. "This investment reinforces our role in ensuring secure, accurate, and environmentally sound land management for all stakeholders."■

noting that their existing Burebasaga Cooperative gives them a strong platform to apply for the TDFF. With this, they could secure a tractor under the 1/3 - 2/3 payment model, where the cooperative contributes onethird and Government covers the rest.

The TLTB team will work to fast-track their application so that they begin mechanized farming, repay the loan, and expand into other ventures including participating in the

nearby chilling centre and seeking support for school transport.

And of course, it wouldn't be Burebasaga without the delicious Tebara cuisine! Our staff were treated to local favourites like rourou vakautona and mana – a perfect end to a meaningful day of service and connection.

# **Court Orders to Dismantle Structures and Take Back Possession of Leased Land**

he iTaukei Land Trust Board (TLTB) is committed to engaging with stakeholders and tenants through collaborative efforts in addressing outstanding lease rental payments. TLTB is pleased to announce a 26% reduction in rental arrears from \$31 million to \$23 million so far between 1st January 2025 and 31st May 2025.

Rent payment is a fundamental term and condition of leases and must be paid on time in January and June each year. Tenants have exclusive possession of the land to provide security, shelter, and livelihoods. The

landowners who allowed their land to be leased out are legally entitled to receive their rental return on time.

There are around 19,331 tenants that are in arrears with 6,276 for agricultural owing \$3.7 million and 13,055 for non-agricultural owing \$18.8 million.

Failure to pay rent can lead to legal action, including eviction from the land. Currently, 500 tenant cases are before the court to enforce payment, and in two instances, TLTB has obtained court orders to dismantle structures and take back

possession of the leased land.

TLTB urges its tenants to prioritise rent payments within their budget. TLTB is

also encouraging tenants facing difficulties in meeting rental obligations to contact their nearest TLTB office promptly to discuss partial payment plans. This initiative aims to provide flexibility and support to tenants to mitigate financial burdens.

For payment convenience, tenants can visit any TLTB office or make deposits through ANZ, BSP, Westpac, BRED. HFC Bank and payments via M-PAISA or at any Post Office, MH and Max Val-U outlets Fiji wide. ■

#### **Toko 999-Year Lease Update**

he iTaukei Land Trust Board (TLTB) wishes to clarify the reports recently published in the media regarding legal proceedings brought before the High Court in Ba against TLTB by persons purporting to represent lease holders in Toko. The proceedings seek to determine, among other things, the question of whether the Board has the powers to unilaterally surrender, cancel, or deal with the land without the consent of the sublessees and the occupants.

An application was also filed for an interim injunction for orders restraining the Board from surrendering, cancelling or otherwise dealing with the Toko leases or subleases. It is not uncommon for the High Court to order an injunction temporarily to allow parties to file their respective affidavits, for the interim injunction

application to be heard, and for the Court to determine whether to order an interim injunction. Such orders, if granted, are intended to maintain the status quo and preserve the rights of the parties until the substantive action is finally determined.

There were reports in the Fiji Sun on 30 May 2025 titled 'TLTB Stopped from Ending Toko Lease' and The Fiji Times titled 'Judge: Hands Off Lease!' on 2 June 2025 on the High Court action. The headlines insinuate incorrectly and quite unfairly that TLTB did, in fact, attempt to end the Toko lease by presenting to the Registrar of Titles a surrender of the Toko lease and/or Toko subleases or otherwise attempted to cancel such lease. TLTB categorically states that the headlines are both misleading and factually incorrect.

TLTB reiterates that it has always endeavoured to work collaboratively with the landowners and tenants to arrive at an equitable arrangement that benefits both the landowners and

tenants alike.The matter is currently before the Courts and therefore remains sub judice. We urge the media to be responsible in its reporting and maintain proper legal and ethical reporting standards.

TLTB affirms its position that no action will be taken to arbitrarily remove any of the residents of the Toko lease nor does it intend to dispossess residents of their occupation of the land. TLTB will in the meantime,

cooperate fully with the orders and directions of the Court and await the Court's determination of the substantive action.

# Software Factory to Develop New Loan Management System

loan disbursements, track repayments, and monitor borrower performance.

"We believe it is only proper to get a purpose-built platform in place that allows us to efficiently manage the entire lifecycle of these loans and provide better support to our landowners," said Mr. Nata.

The new system, known as LoanWorksNGX, will be designed and deployed by Software Factory Ltd, an iTaukei-owned software company with a strong track record in fintech solutions. SFL CEO Mr. Semi Tukana confirmed that the contract

includes the following deliverables:

- Full loan lifecycle management (from application to closure)
- Unlimited user licenses with mobile accessibility
- On-site hosting and cloud integration
- Training for TLTB staff (including IT, Finance, Trust, and TDF teams)
- 30-day postimplementation support
- Compliance with Reserve Bank of Fiji standards and ISO27001 information security protocols

Mr. Tukana added, "We're proud to support TLTB and contribute to this visionary step in empowering iTaukei landowners. This modern solution is designed to boost efficiency and financial transparency while helping landowners thrive in the areas of commerce and investment."

The new credit facility and loan management system is scheduled for launch in July 2025, setting the foundation for smarter, secure, and inclusive financial services under TLTB's evolving mandate.

## Mataqali Nayavulagilagi **Invests Timber Royalties** into Tractors

The iTaukei Land Trust Board (TLTB) has reaffirmed its commitment to empowering landowners with the successful handover of two tractors to the Matagali Nayavulagilagi of Draiba Village, Namataku District in

the highlands of Navosa.

Funded from timber royalties held in trust by TLTB, the Matagali chose not to adopt the Equal Rent Distribution (ERD) system, allowing them to accumulate sufficient

landowners and alternative pathways TLTB offers to help our people achieve economic self-reliance.

Mr. Waisea Colanuku, a representative from the Matagali, expressed heartfelt gratitude during the handover, calling it a turning point for their village. "We've been farming with knives and forks, but today we take a huge step forward. We're

thankful to our forefathers who allowed the lease for logging, and to TLTB for making this investment possible. We hope this is only the beginning."



#### 224 Women Given iTaukei Leases in 2025

This includes 117 iTaukei women and 107 are women from other races: a strong indicator of TLTB's commitment to inclusivity and fair opportunity. Out of the 224 iTaukei women leases, 24 are members of their landowning unit leasing their own land.

CEO Mr. Solomone Nata said that these efforts are part of TLTB's broader strategy to

ensure women are not left behind in the economic use and ownership of land leases.

"Our goal is to remove systemic barriers and ensure women-whether iTaukei or other race-have equal opportunity to access land for residential, agricultural, or commercial use. This aligns directly with our Strategic Corporate Plan 2025-2029, which commits to equity and empowerment for all land users," Mr. Nata said.

Traditionally, access to land in Fiji has been male dominated, especially in customary settings. However,

TLTB is actively working to change that narrative through targeted outreach, simplified leasing processes, and community education programs to encourage women applicants.

The move reflects Fiji's commitment to the UN Sustainable Development Goals (SDGs), particularly Goal 5: Gender Equality, and supports broader national efforts to build an inclusive and just society.

Mr. Nata reaffirmed that TLTB will continue to lead by example by embedding inclusivity into its daily

operations, lease approvals. and land development support services.

"Women have always played a vital role in our communities and economies. Giving them access to land isn't just fairit's smart development," he said.

TLTB is calling on communities, landowners, and development partners to support this movement by encouraging more women to apply for leases and by eliminating cultural or institutional biases that may stand in their way.


